#### **Question One (Compulsory)**

a) Read the excerpt below and answer the question that follow:

Every employee in Kenya is entitled to enjoy the right to strike as articulated in the Constitution of Kenya (2010) and the Labour Relations Act (2007). Teachers in public schools in Kenya exercise the right to strike to compel the State, which is their employer, to address their pertinent needs. However, in most cases, courts have issued injunctions which prevent teachers from exercising their fundamental right to strike.

#### **Questions:**

- Provide five justifications why courts often stop teachers from going on strike. (5 marks)
- ii. Discuss any **five merits** of teachers going on strike **(5 marks)**
- b) Read the excerpt below and answer the question that follow:

In July 2020, Masaibu Masubuko joined Kipepeo Primary School as a new deputy teacher—transferring from another school after facing allegations of sexual assault. Later in the month, he invited two female students from the Kipepeo Primary School, W.J. and L.N., to his house, where he ordered the girls to mop his house and prepare him lunch. During the visit, Mr. Masubuko raped L.N. and later attempted to rape W.J. The children managed to escape and reported the violation to the headteacher of the School.

#### Questions:

- Explain five actions the headteacher should have taken immediately the children reported the case. (5marks)
- ii. Discuss **five challenges** that the headteacher was likely to encounter in handling the case of rape for the two girls. **(5 marks)**
- c) Discuss five justifications for the classification of education as a basic human right. (10 marks)
